However, to enhance the relevance and comprehensiveness of the research, it is suggested that the coverage be extended up to 2023. Furthermore, it is imperative to acknowledge and incorporate insights from other significant crises, such as the European Sovereign Debt Crisis (2009-2012) and the COVID-19 Pandemic Recession, which have had discernible impacts on stock indices.
