Results and Discussion: Separate “Results” and “Discussion” or distinguish them within the same section. This structure allows a clear presentation of findings followed by interpretive insights. Conclusion: Emphasize implications with a short “Practical Implications” subsection. Recommendations: Organize into categories, such as “For Teachers,” “For Administrators,” and “For Policy Makers,” for readability and relevance. These improvements would streamline the manuscript, making it clearer and more accessible for readers.

Local or Regional Studies: If available, recent studies specific to the Philippines or Southeast Asia on educational practices and teacher-student relationships could provide a more locally relevant context for the findings.

For instance, phrases like "appealing classroom organization" might be streamlined to "effective classroom organization" for precision.</p> <p>Academic Tone: The manuscript maintains a formal tone suitable for scholarly work, but minor adjustments, such as avoiding conversational phrases (e.g., "based on the findings, public school teachers may..."), could make it more concise. Overall, the language is appropriate for academic purposes but could benefit from slight refinements in phrasing and structural adjustments for enhanced clarity and flow.</p>
