The minor grammatical and formatting issues need to be resolved.</div>	
<div>Optional/General comments</div>	<div>The draft of the article should be in continuous numbering so that the modifications and amendments required can be referred easily.</div> <div>Abstract</div> <div>The abstract is comprehensive, providing a succinct overview of the background, aim, methodology, and conclusions.</div> <div><ul style="list-style-type: none">End Tuberculosis Strategy is something to be mentioned peculiarly. So, it should be in inverted commas.</div> <div>Introduction</div> <div>The introduction is well setting the context by discussing the background of Mycobacterium tuberculosis, its strains and lineages, and the factors contributing in the spread and resistance development in the strains. However, minor modifications can further enhance the clarity of the context.</div> <div><ul style="list-style-type: none">The quality of introduction could be enhanced by throwing some light on “End Tuberculosis Strategy”, mentioning the incidences of disease in different countries you are mentioning for better understanding in the context.Discuss some potential strategies and their implications in controlling and mitigating the effects of the disease on public health.A few lines on the disease and its mechanism should be added in the introduction to attract the reader’s attention.Compare findings with other studies and discuss potential strategies for implementing genetic programs.</div> <div>Methods</div> <div><ul style="list-style-type: none">As the article is not a research article, so there should not be a methodology section, rather the section could be given some alternative title like Approach, literature search etc.What was the criteria for inclusion or exclusion of data from the databases.The figures should have captions detailing the graphs and graphs.The mechanisms of drug resistance are well explained; However, a better understanding can be provided to readers by adding some diagrammatic illustrations.</div> <div>Future Directions and Recommendations</div> <div><ul style="list-style-type: none">Add some details of medicinal anti tuberculosis plant, its effect and potential in treating the disease.</div> <div>Address minor grammatical and formatting issues in the article to improve readability.</div>
