Recent studies in areas such as cognitive load theory in classroom contexts, modern instructional strategies (including digital and blended learning), and updated perspectives on learning metaphors could enhance the discussion. Suggested additions include:</p> <ol style="list-style-type: none">1. Studies on recent advancements in “Cognitive Load Theory” within educational settings.2. Research on contemporary “instructional strategies”, especially those involving digital or blended approaches in teaching.3. Recent reviews or meta-analyses on “learning metaphors in cognitive and educational psychology”, which build on Lakoff & Johnson's work and explore how metaphors impact learning in varied contexts. <p>Incorporating recent studies would align the manuscript with current research trends and increase its relevance and credibility.</p>
