Figure 1 – 10; Please try to designate each figures at the end of equivalent explanations in the manuscript. Is the number of figures appropriate to the restriction of the journal? Ten figures are usually too many for a case report. Some reports suggest sclerotherapy because it is less invasive. Please cite the following articles on the sclerotherapy for lymphangioma, and add small comments about the superiority of surgical excision, such as curability and diagnosis. • Combined Treatment with Lymphaticovenular Anastomosis and Ethanol Sclerotherapy for Cystic Lymphangioma in a Limb.
