Optional/General comments	As the study focuses on the intervention (the Ethanol Ablation) carried out it is very much essential to describe the procedure and the role of ethanol in the procedure and how this procedure is more beneficial compared to other ablative procedures. The introduction that is in the abstract in the same exact sentences that are stated in the actual introduction, which would create a opinion in the minds of reader that the same things are been said again and again and there is no need to study the complete paper, this is how the interest of the reader is lost.
