The title of article is well chosen; however the structure and content of the article does not fully reveal what is implied by the title 3. Has to be rewritten in accordance with the structure change 4. Parts 2.1-2.4 and Part 3 are very well written; however the whole structure should be amended reflecting all three domains mentioned in the title: Decision Making Process /Palliative Care Interventions /Communication to Patients/Families, based on 3 different ICU-PC models. 5. More evidence-based facts on outcomes of properly taken decisions and its effectiveness in PC interventions should be given. Comments are in the text. Also, change of structure remains basic comment. 6. The current and additional references are mentioned in the text.
