<div>Optional/General comments</div>	<div>The paper provides an interesting overview of how climate change impacts Arctic navigation and affects Taiwan's economy. The paper is concise and easy to understand, offering valuable insights that could benefit future studies in this field. However, there are both major and minor issues that need to be addressed before the paper can be accepted.</div> <div>Minor Comments</div> <div><div>1. The broad citations help in understanding the impacts of climate change on the economy. However, the paper could use additional references that are uniquely relevant to Taiwan's economy.</div><div>2. The paper has limited information on the central argument, which becomes obscured by extensive climate and Arctic content. It would also be beneficial to clarify terms like "blue economy."</div><div>3. It is recommended to eliminate overlapping information in the Background and Literature Review sections. A suggested flow could cover how climate change opens Arctic routes, the strategic importance of these routes, and their connection to Taiwan's economy.</div><div>4. The paper needs minor grammar fixes and shorter sentences. Make sure any unwanted bullet points in the reference section are removed before the final submission.</div></div> <div>Major Comment</div> <div><div>1. The discussion would benefit from a clearer analysis of how Arctic changes impact Taiwan's socio-economic activities beyond trade. Consider including an overview of international law for specific industries or social sectors in Taiwan (e.g., tourism, fishing, resource import/export) that may be directly influenced by increased Arctic accessibility.
