Also, images and raster files means the same in your sentence. The use of satellite..." this does not clarify which methods were primary and which were secondary. Please rephrase accordingly.Section 2.4, second last sentence ... ArcGIS 10.2 soft ware was also... did you mean "software"?Under chapter 3: titled: 3. RESULTS ANALYSIS AND DISCUSSIONS, verify the word "... buoyance, just before Fig 6.You made reference to Table 4 as ... The table above shows the rotated. Such language could mean every table above. Also verify that the table means Table with information! As text below Table 6.Figure 10, 11, 12 and 13 are just inserted in this manuscript without description of those Figure.
