I think it would be better to introduce the data on the climate of Brazil at each of these periods in order to observe the possible variations</p> <p>7. In manuscript (Table 2 and Table 3) Why present 2017 and 2018 data here when malaria incidence section presented 2018 and 2019 data?</p> <p>8. In manuscript (Table 2 and Table 3) I do not agree with the calculation of the differences that you have expressed as a percentage. Explain how you proceeded to get these data.</p> <p>9. I suggest that you detail your calculation methods in the material and method section</p>	Noted
