Fetal ultrasonography is useful for dating when the last menstrual period (LMP) is uncertain.</p> <p>This line can be replaced with better wording and more meaning to the sentence like suggested sentence be reframed as</p> <p><b>Fetal ultrasonography of crown rump length accurately determines the gestation age in first and second trimester of pregnancy when the last menstrual period (LMP) is uncertain</b></p> <p>2. Studies have shown that about 30% of pregnant women forget the date of their LMP</p> <p>Kindly provide reference for this. “Studies” word can be replaced by “Literature” Put full stop after this sentence</p> <p>3. Reframe the main objective of the study as it sounds disconnected with reasons mentioned earlier. I have suggested sentence here.</p> <p>“When the gestational age is not accurately known, the progression of pregnancy can become unpredictable with an unfavourable outcome. To have a predictable course in antenatal period and a safe labour especially in the third trimester, ultrasonography measurement of fetal kidney length can be used as a tool to determine the exact gestational age in the third trimester of pregnancy.”</p> <p><b>Method Section of Abstract</b></p> <p>1. Kindly state the- Study set up, design, place, duration and type of study done 2.Full form of “BPD, AC&amp; FL” have to be mentioned as it has been for the first time in text. 3.Clearly mentioned the number of study participants in group 1 and 2. Incorporate terms such as control group and test group in methods</p> <p><b>Result section of Abstract</b></p> <p>1. IUGR: use full form when used first in the text and latter abbreviated can be used 2. The following sentence is not grammatically correct. Kindly reframe it. Make it into sentences The mean length and width of the left kidney were similar in both groups, as the mean length of the left kidney in the IUGR group was (38.40 ± 4.000) while it was in the control group (38.17 ± 3.637).</p> <p>3. The following sentence is not grammatically correct. Kindly reframe it. Make it into sentences</p> <p>The average width of the left kidney in the intrauterine growth restriction group</p>	Thanks

	<p>was (23.09 ± 2.339) while it was in the control group (23.16 ± 2.341), there were significant positive correlations between the different study variables</p> <p>4. Kindly state who is “they” in the last line of results . And reframe the sentence like: <u>use both right and left kidneys in last sentence instead of repeating again about left kidney association</u></p> <p>“they also found a positive association with the length of the left kidney.”</p> <p>Conclusion section of abstract</p> <ol style="list-style-type: none"><li>1. Reframe the conclusion paragraph as it is grammatically incorrect</li><li>2. Use full form for Rt and Lt Kindly see the suggested conclusion</li></ol> <p>With respective to the fetal growth and gender there was no difference in measurements in terms of length, weight and volume parameters used for both right and left kidneys. Hence, in the absence of renal anomalies or abnormalities’, these parameters can be employed as a reliable indicator to determine the exact gestational age of the fetus</p> <p><b>Introduction section</b></p> <ol style="list-style-type: none"><li>1. Correct the first line: Obstetric ultrasound is the initial imaging method used to evaluate the fetus and monitor growth ( evaluate fetal outcome), change the word ultrasound to ultrasonography</li><li>2. In the second sentence use this -dating pregnancy</li><li>3. Labor or labour use one word in text to maintain uniformity</li><li>4. Check for grammatic mistakes in the text of introduction paragraph.</li><li>5. Please remove unnecessary investigation or parameters mentioned.</u></li></ol> <p><b>Statistical section</b></p> <p>1.Type of computer need not be mentioned , software version is Sufficient</p> <p><b>Results section</b></p> <ol style="list-style-type: none"><li>1. If single number are used put it in full spelling instead of digits</li><li>2. As fetal doppler study table is mentioned, add a not in abstract part of methodology also.</li></ol> <p><b>Discussion section</b></p> <ol style="list-style-type: none"><li>1. First paragraph last line stating the objection: incorporate the word “normal” kidney</li><li>2. In second para clearly mention that it is the gestational age of pregnant women and not age in years</li><li>3. In third paragraph correct the spelling : period</li><li>4.
