It would be very useful to add in the "<i>Introduction</i>" section the purpose, objectives and hypothesis of the research.3. We consider that the introduction should specify the novelty of the paper compared to other papers published in this area.4. We recommend that the authors take the VIF test to eliminate multicollinearity.5. For descriptive statistics, we recommend that the authors present the Jarque-Bera, Kurtosis, etc. tests and explain whether the variables follow the normal distribution law according to the probability associated with the Jarque Bera test.6. Also, we consider the literature is not enough and that is why, we recommend the authors to refer to other recent works indexed in Web of Science, Scopus, Emerald, Cambrige, and MDPI Journals.
