Table 3 says "home based pulmonary rehabilitation program" and the correct is "home-based pulmonary rehabilitation program".</p> <p>Line 130 says "However, zoom (n=319) (28.7%) was the most used platform for telerehabilitation programs" no data is found in table 5.</p> <p>Line 144 says "significant barrier n=351, 28.4%" and the correct is "significant barrier n=315, 28.4%"</p>	All the necessary corrections were done as indicated
