I suggest also to summarize it. Also, you mentioned the aims and objectives at the end of introduction as points, I suggest to add it to the last paragraph as a phrase.</p> <p>3- 3-Materials and methods:</p> <p>4- -How did you calculate the sample size?</p> <p>-The study period from November 2020 to October 2022 was repeated more than one time.</p> <p>It should be mentioned once at the beginning of material and methods section.</p> <p>-Classifications of BMI should be written as a paragraph. Also, The standard parameters for radiography and measurement of the lumbosacral angle.</p> <p>-Inclusion criteria: the second point (The research enrolled only People who had reached spinal maturity (Adult) has the same meaning of the first point (Their age range was between 20 and 60).</p> <p>-What are other inclusion criteria regarding the type of back pain, its severity? How it was diagnosed?</p> <p>-It is better to write inclusion &amp; exclusion criteria as a paragraph.</p> <p>4-Statistical analysis:</p> <p>-What is the test that will be used for statistical analysis?</p> <p>5-References: You should check the arrangement of the references in the whole paper.</p>	Correction done as per the advice of the reviewer in the manuscript and all its sections.
<b>Minor</b> REVISION comments	<p>-Correct mistakes in spelling, grammar and punctuation in the whole paper.</p> <p>- The abbreviations (LBP, T2DM and OSA) were already mentioned in full words in the abstract.
