The conclusion should indicate:</p> <ol style="list-style-type: none"><li>1. How the ideas in the paper connect to what scholars have written in their treatment of the research topic.</li><li>2. What new ideas author (s) have added to the conversation and what ideas in the literature were critiqued.</li><li>3. What the author (s) thinks are the limitations of the data used, methods, or results.</li><li>4. What author (s) thinks are the consequences or implications of the strongest idea that comes out of the paper for policy or practice.</li></ol> <p><b>Reference list</b> The references do not appear in the paper so one therefore, wonders where they come from.</p>
