	Keywords The manuscript presents four keywords. For keywords, where possible, please use Medical Subject Headings terms (MeSH Terms). None of them is a MeSH term. An alternative MeSH term proposed could be "dentistry, operative" better than "restorative dentistry". These suggestions about keywords are optional, not mandatory.
