specialties specialties and Membership in 22 disciplines. The duration of the FCPS training varies from 4.-to.5 years depending upon the specialties chosen. Competency-based Competency based curricula have been developed for each discipline by the relevant faculties. More than 29,000 training slots have been awarded in 263 CPSP accredited medical institutions throughout the country. The College critically evaluates the standards and facilities available in these institutions to ensure quality training for its trainees.

However, But even after the allocation of seats and supervisors awhy is that After clearing FCPS part I, getting inductedion into the training program of FCPS part II is theremains a toughest thing in this very ora?challenge at this point in time.

It is the competition, but the unfair means of selection criteria, merit has lost its weighting age. The other problem is the shortage of supervisors required under the criteria of the College of Physicians and Surgeons Pakistan (CPSP). Despite having the criteria in place, most of the applicants are left unaccommodated due to shortage in supervisors has diminished over the years due to which all applicants cannot be accommodated.

Another study Studies have reported that the petitioner also mentioned the "unlawful" act of the health department while giving weightage to the FCPS candidates by violating the seat distribution criteria. However, not even the alloted number of seats were given to the FCPS candidates.

## **Conclusion:**

<u>Therefore.</u> CPSP needs to make sure that every individual who clears FCPS part I <u>getsget</u> the opportunity to continue their part II training in their desired <u>discipline. This can be done by discipline by increasing the number of seats per speciality and also by increasing the number of supervisors for the candidates. <u>E</u>each supervisor must have 8 candidates under them without any <u>biases</u> considering merit as sole criteria.</u>
