	[1] The manuscript is very crudely written. There are huge typographical, grammatical and structural mistakes from the Title to References. These make the manuscript unsuitable for publication as a research article in its present form.  [2] The shrub name 'Rauwolfia vomitoria' must be italic throughout the manuscript.  [3] Authors must know the appropriate spelling, small letter and capital letter placement.  [4] Figure 1 must be clear and caption should be below the Figure.  [5] In the experimental section, please remove unnecessary tests. Just provide reference(s) by which the test is done.  [6] Use space in 22mm; use either mL or cm³; use '48 h' instead of '48hrs' and so on; use 'RESULTS AND DISCUSSION'; use 'Figure 1' or 'Fig. 1' instead of 'fig1';  [7] Compounds name as presented in 'GC-MS Analysis' section must be revised with appropriate nomenclature style. In addition, the name, MF, peak(s), structures etc. should be compiled in one Table and no need to repeat it in the discussion.  I highly emphasize authors' careful major revision and structural organization of the manuscript and resubmit it for review.	
Minor REVISION comments		
Optional/General comments	There are many reports for the extracts and uses of 'Rauwolfia vomitoria Afzel. Hence, authors must be careful about repetition of the work.  More importantly, only a GC-MS can't confirm the structure of compounds. Chromatographic separations followed by spectroscopic analysis are essential in this regard.
