<u>Compulsory</u> REVISION comments	<p>In your results, the figures are not commented; add comments to make it easier for readers to understand.</p> <p>Review references according to the guide for authors: References must be listed at the end of the manuscript and numbered in the order that they appear in the text. Every reference referred in the text must also be present in the reference list and vice versa. In the text, citations should be indicated by the reference number in brackets [3].</p>	
<u>Minor</u> REVISION comments	<p>Abstract Part: Descriptive details needed in the methodology and not in the abstract . If possible delete and reformulate the method part of the summary so as to highlight the evaluation of the hepatoprotective parameters as well as the lipid profile which are not mentioned in this part although they are an integral part of your objective. It is not necessary to specify here the duration of induction of diabetes; otherwise also specify the duration of treatment of the rats with honey.</p> <p>In keywords, delete"bilirubin" as it's redundancy since you are quoting liver function.</p> <p>In paragraph 3 of the part 1.Introduction, put the reference if possible for the part: "Several studies have shown that honey can be used as an antioxidant anti-inflammatory; wound healing, and recent research showed that honey has anti-diabetic effects." Same remark for the next sentence in the 4th paragraph.</p> <p>In part 2.1., you do not specify the sex of the animals used. Specify whether they are male or female rats.</p> <p>In part 2.3, The number of doses of alloxan monohydrate used per rat as well as the duration of induction of diabetes are not mentioned; If possible specify them.</p> <p>Still in part 2.3. ,What is the mode of treatment used: is it the curative mode? or the induction of diabetes and the treatment take place simultaneously. Specify if possible.</p> <p>Revise numbering 2.6 and 2.7 for consistency.</p> <p>In the paragraph 2 of part 4.Discussion, conjugating the verb "can" in the conditional in the differents sentences.</p> <p>In the part 5. Conclusion, you do not highlight the effect of honey on blood sugar which seems to be the most important in your study.</p>
