	<ol> <li>The abstract must contains the main purpose of the paper, the research method used in the research and the main contributions.</li> <li>It would be very useful to add in the "Introduction" section the purpose, objectives and hypothesis of the research.</li> <li>We consider that the introduction should specify the novelty of the paper compared to other papers published in this area.</li> <li>I consider that the VIF test shows a possible multicollinearity between the independent variables.</li> <li>I believe that the paper can be improved if an econometric analysis is done with fixed effects and variable cross-section time effects.</li> <li>Also, we consider the literature is not enough and that is why, we recommend the authors to refer to other recent works indexed in Web of Science, Scopus, Emerald, Cambrige, and MDPI Journals. We suggest that the authors cite papers published in MDPI journals and Web of Science Journals.</li> <li>I propose to the authors the structuring of the paper on the following sections without numbering: Introduction, Literature review, Method and Results and Conclusions.</li> <li>In conclusion, the paper can be published after minor revisions.
