This is the classic classification; more and more authors tend to add: type 0, type 1.5, and type V. eg: <a href="https://radiopaedia.org/articles/chiari-malformations">https://radiopaedia.org/articles/chiari-malformations</a>.</li><li>- <b>Material and methods:</b> There is a 2020 update of PRISMA, precise that you are using the 2009 version. And it seems better to include it in your references list. Go to the official site web of PRISMA <a href="http://www.prisma-statement.org/">http://www.prisma-statement.org/</a></li><li>- <b>In Methodology and in Search methods</b> you say "databases searched from January 1997 to March 2017"; in <b>Material and methods</b> you say "with no restriction on the year of publication" precise or explain it.</li><li>- <b>Overall complication {whats the definition of overall complications?- needs to be defined in the text}</b>: I think that this phrase is not supposed to be published !!!</li><li>- <b>Discussion:</b> "Post-operative symptomatic clinical improvement": put it in a complete phrase.</li></ul>	
<b><u>Minor</u></b> REVISION comments	<ul style="list-style-type: none"><li>- <b>paediatric population:</b> define an age limit.</li><li>- In no place you cite figures in your text.</li><li>- In figure 1 you wrote "Fig 1" in other figures "figure": correct it.</li><li>- <b>Overall complication</b> : [14, 18, 19, 21) : correct it.</li><li>- TABLE 1: Lee 2014 not Les 2014. correct it</li></ul>	
<b><u>Optional/General</u></b> comments	<ul style="list-style-type: none"><li>- <b>Introduction</b> "decompression heralds Rclinical": correct it</li><li>- Include DOI in your references wherever is possible.</li></ul>
