<b>Compulsory</b> REVISION comments	<p>The manuscript entitled "COVID-19 vaccine uptake and its determinants among adult population in Somali region of Ethiopia" falls within the scope of Journal of Advances in Medicine and Medical Research. However, it needs a major revision before it can be accepted.</p> <p><b>Introduction:</b> The literature review does not find the gaps in the current research and hence it is difficult to see the innovations made in this study. What is the significance/practical implication of this study?</p> <p><b>Method:</b> There is insufficient information on the data quality and data preparation. Specify the exact data collection duration and time. It is not clear that how the authors selected variables for the multiple logistic regression. I mean need to specify how independent variables are entered into the multiple logistic regression. The degree of correlation between the predictor variables and outcome variables or FORWARD/ BACKWARD/STEPWISE variable selection approach can be used (Please see <a href="http://dx.doi.org/10.1136/bmjopen-2020-045506">http://dx.doi.org/10.1136/bmjopen-2020-045506</a> and <a href="https://doi.org/10.1101/2022.01.31.22270172">https://doi.org/10.1101/2022.01.31.22270172</a> ) .</p> <p><b>Results:</b> Results are well described. However, writing quality is very poor. In Figure 1, one option is missing (5 bars but only 4 options). What does (<math>\chi^2</math> 67.776, p&lt;0.05 ) mean? The number of decimal values is not consistent for test statistics and p-values.</p> <p><b>Discussion:</b> Compare your results with similar studies done internationally (e.g. <a href="https://doi.org/10.1371/journal.pone.0257096">https://doi.org/10.1371/journal.pone.0257096</a> ) .</p>	
<b>Minor</b> REVISION comments	Writing needs improvement, at many locations, the writing is poor.
