Grammar, punctuation, or structure mistakes in the article</p> <p>This paper has several errors in grammar/language structure, and punctuation:</p> <p>(a) The abbreviation et al appears to be lacking punctuation. Consider changing “et al” with “et al.”</p> <p>Note: Make the same changes throughout the manuscript.</p> <p>(b) On page 14, second paragraph, lines 6 and 7, the sentence “Aside from their effect on normal leukocyte dispersion” appears to be an incomplete sentence. Consider rewriting the sentence or connecting the fragment with another sentence. Note: It may be a continuation of the previous sentence. If so, then replace ". Aside ..." with ", aside"</p> <p>II. Comments from reviewers on the writing format and content of the article</p> <p>In the Article Title</p> <p>The article title should be informative and contain highlights from finding the article content. Avoid using possessive adjectives like your/our/my/his/her/their.
