	remains an", 2-, 4- and 8-ml body weight of the extract", "rats were m at monitored". 3. Revise the first line of Introduction "Citrus aurantium also known as bitter orange, sour orange or Oroma Inu [1] is an	
	3. Revise the first line of Introduction "Citrus aurantium also known as bitter orange, sour orange or Oroma Inu [1] is an easily available tree"	
	4. Take a revision on these saying "The major active citrus herbs are mainly" "bitter orange its strong odor" "bitter
