<u>Compulsory</u> REVISION comments	<p>The abstract needs total overhaul. It is quite difficult to understand, may be due to poor punctuation. I have suggested edits in the comments section of the manuscript.</p> <p>There are lots of grammatical errors. The author (s) should please go through and review the entire manuscript. Some corrections/suggestions have also been made.</p> <p>The referencing style used in the manuscript for articles, chapters in books, and books does not follow the Journal of Pharmaceutical Research International format. For instance, the author s have cited this article as:</p> <p>Michels, KB. Nutritional epidemiology—past, present, future.</p> <p>But the complete reference is:</p> <p>Michels KB. Nutritional epidemiology--past, present, future. Int J Epidemiol. 2003 Aug;32(4):486-8. doi: 10.1093/ije/dyg216. PMID: 12913011.</p> <p>Most of the references even though a doi is available, the author (s) have not quoted them. Authors are encouraged to utilize doi where available.</p> <p>Also, the first reference was cited in the manuscript as: Alexander, D.D., Bylsma, L.C., Vargas, A.J., Cohen, S.S., Doucette, A., Mohamed, M., Irvin, S.R., Miller, P.E., Watson, H. and Fryzek, J.P., 2016. Dairy consumption and CVD: a systematic review and meta-analysis. British Journal of Nutrition, 115(4), pp.737-750.</p> <p>The surname and initials of the first six authors should be written followed by et al. As such this article should be cited as: Alexander DD, Bylsma LC, Vargas AJ, Cohen SS, Doucette A, Mohamed M, et al. Dairy consumption and CVD: a systematic review and meta-analysis. Br J Nutr. 2016 Feb 28;115(4):737-50. doi: 10.1017/S0007114515005000.</p> <p>Check all the references again to ensure you have cited all of them and they conform to the journals format.</p>	
<u>Minor</u> REVISION comments	<p>Please remove 'pp' before inserting the page numbers. This style does not conform to the journals recommendation.</p> <p>Except it is the journals format, I suggest that the colon symbol should be removed from Chapter headings and sub-headings. For instance in Section 4,5, and others , there is a colon at the end of the heading. Please go through the manuscript and correct appropriately.</p> <p>Paragraph 1, Line 5, Section 4(Biomarkers of Nutritional Epidemiology). The sentence is incomplete. Please check and correct appropriately.</p> <p>Also maintain uniformity in the use of et al at the end of sentences. For example paragraph 2, line 6, section 4, you have cited the reference as Beaton et al. 1997, but it should be Beaton et al., 1997.</p> <p>Chapter 6, I think you need to amend the nomenclature of the Chapter heading. It</p>

	<p>doesn't portray the meaning you intend it to convey. It is currently stated as 'Nutritional Epidemiology studies are currently studied'. I don't know if you mean to write 'Current Research in Nutritional Epidemiology' or 'A Review of Current Nutritional Epidemiological studies'.</p> <p>Also, I have made minor amends to the write up in section 6. Could you please read this to ensure that it conveys the message that you intend?</p> <p>Lines 8 and 9, subsection 6.1, you have cited American Institute for Cancer Research and World Cancer Research Fund International, 1997 but I think the correct reference is</p> <p>'Glade MJ. Food, nutrition, and the prevention of cancer: a global perspective. American Institute for Cancer Research/World Cancer Research Fund, American Institute for Cancer Research, 1997. Nutrition. 1999 Jun;15(6):523-6. doi: 10.1016/s0899-9007(99)00021-0. PMID: 10378216.</p>	
<u>Optional/General</u> comments	<p>Maintain uniformity in heading titles. I mean if you want to capitalize the first name for each word do so.</p> <p>Recheck to ensure all the references have been cited, and appropriately too.</p>
