Please provide more information about the intradialytic stretching exercises, such as the type, frequency, duration, and so on. 7. Please provide more information of control group. Did they do any exercise during study period? 8. Why not include patients younger than 30 years old or older than 60 years old? 9. Were all participants with chronic haemodialysis (longer than 3 months)? 10. The authors did not report the sensitivity and specificity of the cramp questionnaire. 11. Please mention the definition of post test-3, 3rd post test in the "MATERIAL AND METHODS".
