The methodology must be better explained. The way that the groups are described is confusing, so, it makes hard to understand the results and discussion.5. At the methodology, first describe all the methods and tests that were performed, Then, describe how do you divided your groups and subgroups. Ex: Group A= teenagers; Group B – Adults; Subgroups: Ct=Control (specify the parameters); SCH1 = Describe the group and specify the parameters; SCH2 – describe the group and specify the parameters!!6. Why do you seek to present the differences between groups A and B.? It is already expected that they will be different! You can keep this information, but you need to discuss it properly.7. In you discussion, there are issues that must be reviewed. You should include a paragraph about the problems with subclinical hypothyroidism and why it is important to investigate it.8. In your study, you aimed to associate subclinical hypothyroidism whit lipid levels. Your conclusion must be according with your findings.
