<u>Compulsory</u> REVISION comments	<p>Abstract:</p> <ul style="list-style-type: none">• Exceed 400 words and it contains some repeated words, also no key words present which reflect the main concepts of the article.• It contains abbreviations which may not be known for readers.• Abstract included COVID 19 among birds and animals which are not mentioned again in the article. <p>Introduction:</p> <ul style="list-style-type: none">• Must include a paragraph about the significance of the topic and its actual or potential effect (impact of myths on individuals), especially since it is superficially mentioned in the abstract.• Avoid answering on myths by yes, no or false instead of it can be written based on evidence based researches because we cannot judge it by our own opinion.• Some answers on myths don't contain reference which is not scientific based.• Answering myths need to be more comprehensive and discussed by more evidence and compared by different sources not only one source. <p>Discussion and conclusion must be clear by its title for the reader.</p> <p>References:</p> <ul style="list-style-type: none">• Some references are not included inside the article as reference 8, 11 & 14.• Reference 10, 12, 13, 15 must be written by the same way like other references.
