The yield of the seed mucilage of <i>Lepidium Sativum</i> was optimized by using a quality by design approach. The article sounds good i appreciate their efforts however, the following changes would make it more interesting for the readers, and I think it could be published with major revisions. The authors have cited several relevant references to build up the present model's literature review. However, it is not sufficient. It is vast but not comprehensively focused on the relevance of the problem chosen in the manuscript. Authors should update the introduction section by including recent articles published explicitly in the last two-three years. For example, 10.21203/rs.3.rs-810314/v1, and 10.26717/BJSTR.2021.34.005492. 10.3390/polym13132089, 10.1007/s10924-021-02142-1, 10.3389/fbioe.2021.797672.</p> <ol style="list-style-type: none">Add some quantitative and qualitative data in the conclusion.Rewrite this with new references. The different plant-derived products are highly enriched with different phytochemical constituents, showing different therapeutic activities against critical and chronic diseases`The different levels of variables along with coded and un-coded factors of experimental design are presented in table 2 and table 3. Rewrite this.However, based on the design of experiment trials the modified extraction process was proposed. Need to improve.There are so many mistakes in writing please check carefully.
